

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Veterans Affairs Office Donation & Contribution Budget
Amendment No. 1)**

RESOLUTION NO. 18-112

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Veterans Affairs Office Donation & Contribution Budget in the
8 amount of \$85,400 was approved by Resolution No. 17-437; and

9 **WHEREAS,** the Veterans Affairs Office has prepared and submitted for review and approval
10 its FY 2018 Donation & Contribution Budget Amendment No. 1, which is
11 incorporated by this reference and which will adjust operational line items and
12 add a line item; and

13 **WHEREAS,** the FY 2018 Veterans Affairs Office Donation & Contribution Budget Amendment
14 No. 1 will increase the Budget by \$500 from \$85,400 to \$85,900; and

15 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
16 reviewed the FY 2018 Veterans Affairs Office Donation & Contribution Budget
17 Amendment No. 1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2018 Veterans Affairs Office Donation & Contribution Budget Amendment No.
20 1, which includes a \$500 increase from \$85,400 to \$85,900 that shall be funded by
21 revenue donations.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2018 Veterans Affairs Office Donation & Contribution Budget as
25 amended, provided however, that any amendments or modifications shall be
26 submitted for prior approval by the Tohono O'odham Legislative Council.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
