

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Tohono O'odham Nation Health Care Sells Hospital Rental  
Units Budget Amendment No. 1)**

**RESOLUTION NO. 18-115**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Tohono O'odham Nation Health Care ("TONHC") Sells Hospital Rental**  
8 **Units Budget in the amount of \$152,072.00 was approved by Resolution No. 17-471;**  
9 **and**

10 **WHEREAS, TONHC has prepared and submitted for review and approval its FY 2018 Sells**  
11 **Hospital Rental Units Budget Amendment No. 1, which is incorporated by this**  
12 **reference and which will adjust operational line items; and**

13 **WHEREAS, the FY 2018 TONHC Sells Hospital Rental Units Budget Amendment No. 1 will**  
14 **increase the FY 2018 TONHC Sells Hospital Rental Units Budget by \$6,699.97 from**  
15 **\$152,072.00 to \$158,771.97; and**

16 **WHEREAS, the TONHC Governing Board, Health and Human Services and Budget and**  
17 **Finance Committees have reviewed the FY 2018 TONHC Sells Hospital Rental**  
18 **Units Budget Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2018 TONHC Sells Hospital Rental Units Budget Amendment No. 1, which**  
21 **includes a \$6,699.97 increase from \$152,072.00 to \$158,771.97 that shall be funded**  
22 **by Indian Health Service.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2018 TONHC Sells Hospital Rental Units Budget as amended,**  
26 **provided however, that any amendments or modifications shall be submitted to**  
27 **the Tohono O'odham Legislative Council for prior approval.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
29 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**
