

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Natural Resources Cultural Center & Museum
Collections and Curation Budget)**

RESOLUTION NO. 18-127

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Cultural Center & Museum received a \$1,000.00 donation from the Bureau of**
8 **Land Management and a \$39,300.00 donation from Desert Archaeology, Inc.**
9 **totaling \$40,300.00, which is currently deposited in the Museum's**
10 **Donations/Contributions account 001-0000-4851 for use by the Tohono O'odham**
11 **Nation Cultural Center & Museum; and**

12 **WHEREAS, the Department of Natural Resources Cultural Center & Museum has prepared**
13 **and submitted for review and approval its FY 2018 Cultural Center & Museum**
14 **Collections and Curation Budget, which is incorporated by this reference, in the**
15 **amount of \$40,300.00 to be funded from the Museum's Donations/Contributions**
16 **account 001-0000-4851; and**

17 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
18 **FY 2018 Cultural Center & Museum Collections and Curation Budget and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2018 Department of Natural Resources Cultural Center & Museum Collections**
22 **and Curation Budget effective October 1, 2017 in the amount of \$40,300.00, which**
23 **shall be funded by the Museum's Donations/Contributions account 001-0000-**
24 **4851.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2018 Department of Natural Resources Cultural Center & Museum**
28 **Collections and Curation Budget, provided that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**
