

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Agreement between Health Current and the Tohono O'odham Nation)**

**RESOLUTION NO. 18-130**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power "to consult, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**  
5 **or with private persons or organizations on all matters within the authority of the**  
6 **Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, Tohono O'odham Nation Health Care ("TONHC") is required to conduct**  
8 **performance improvement projects as a Conditions of Participation for Centers**  
9 **for Medicare and Medicaid (CMS); and**

10 **WHEREAS, this Agreement with Health Current will assist TONHC in obtaining Patient**  
11 **Centered Medical Home (PCMH) recognition; and**

12 **WHEREAS, the purpose of this Agreement is to establish a secure platform for sharing**  
13 **electronic health information in order to reduce health care costs, improve**  
14 **patient safety, and improve the quality and efficiency of health care; and**

15 **WHEREAS, the Health and Human Services Committee of the Legislative Council has**  
16 **reviewed this Agreement and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
18 **approves the Agreement between Health Current and the Tohono O'odham**  
19 **Nation, substantially in the form attached hereto, and authorizes the**  
20 **Chairperson of the Nation, or his designated official to sign this Agreement.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
22 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
23 **AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
24 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
27 **(48 Stat.984).**
