

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Pisinemo District Budget Amendment No. 1)**

**RESOLUTION NO. 18-133**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3           **No district council shall expend district funds except pursuant to budgets**  
4           **authorized under resolutions of the district council and approved by the**  
5           **Tohono O'odham Council. The management of these funds shall be only by**  
6           **a treasurer or other authorized officer of the district council who has**  
7           **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8           **O'odham Nation, and all expenditures of these funds shall be by checks**  
9           **signed by such treasurer or other authorized officer and the chairman or**  
10           **vice chairman of the district council.**

12 **WHEREAS,** the FY 2018 Pisinemo District Budget in the amount of \$3,058,076.43 was  
13 authorized by Pisinemo District Resolution No. 17-P-35 and approved by  
14 Legislative Council Resolution No. 17-422; and

15 **WHEREAS,** by Pisinemo District Council Resolution No. 18-P-06, the Pisinemo District has  
16 authorized and submitted for review and approval its FY 2018 Pisinemo District  
17 Budget Amendment No. 1, which is incorporated by this reference and which will  
18 adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2018 Pisinemo District Budget Amendment No. 1 will not increase the FY  
20 2018 Pisinemo District Budget nor change the total budget amount; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Pisinemo District  
22 Budget Amendment No. 1 and recommends its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
24 **FY 2018 Pisinemo District Budget Amendment No. 1** which will not change the  
25 **total budget amount of \$3,058,076.43.**

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018 Pisinemo  
27 **District Budget as amended shall be managed and expended in accordance with**  
28 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**  
29 **Nation's laws, provided that any amendments or modifications shall be**  
30 **authorized under District Council resolution and submitted for prior approval by**  
31 **the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>th</sup> day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
