

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Public Safety Law Enforcement Budget Amendment No. 1)

RESOLUTION NO. 18-136

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Public Safety Law Enforcement Budget in the amount**
8 **of \$8,154,466.72 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
10 **approval its FY 2018 Law Enforcement Budget Amendment No. 1, which is**
11 **incorporated by this reference and which increases and decreases personnel and**
12 **operational costs, but does not change the total budget amount \$8,154,466.72;**
13 **and**

14 **WHEREAS, the FY 2018 Department of Public Safety Law Enforcement Budget Amendment**
15 **No. 1 will cost share salaries with the U. S. Department of Justice, COPS Hiring**
16 **Grants, Award No. 2013UMWX0010 and Award No. 2014UMWX0024; and**

17 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
18 **2018 Department of Public Safety Law Enforcement Budget Amendment No. 1 and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2018 Department of Public Safety Law Enforcement Budget Amendment No. 1**
22 **effective October 1, 2017, which does not change the total budget amount of**
23 **\$8,154,466.72 and shall be funded by the Nation's general fund and the U.S.**
24 **Department of Justice, COPS Hiring Grants, Award No. 2013UMWX0010 and Award**
25 **No. 2014UMWX0024.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2018 Department of Public Safety Law Enforcement Budget as**
29 **amended, provided however, that any amendments or modifications shall be**
30 **submitted for prior approval by the Tohono O'odham Legislative Council.**
