

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Education Department Child Care Services Program Child Care and
Development Fund Discretionary and Mandatory Carry Forward Budgets)

RESOLUTION NO. 18-153

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on November 1, 2016, the United States Department of Health and Human**
8 **Services Administration for Children and Families awarded the Tohono O'odham**
9 **Nation a FY 2017 grant in the amount of \$1,268,530.00 for a two-year project**
10 **period ending September 30, 2018, of which \$288,166.00 has been identified as the**
11 **total carry forward amount for FY 2018; and**

12 **WHEREAS, the Education Department Child Care Services Program has prepared and**
13 **submitted for review and approval its FY 2018 Child Care and Development Fund**
14 **Discretionary and Mandatory Carry Forward Budgets, which are incorporated by**
15 **this reference, in the total amount of \$288,166.00 to be funded from the Nation's**
16 **general fund pending reimbursement from the grantor; and**

17 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
18 **reviewed the FY 2018 Education Department Child Care Services Program Child**
19 **Care and Development Fund Discretionary and Mandatory Carry Forward**
20 **Budgets and recommend their approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2018 Education Department Child Care Services Program Child Care and**
23 **Development Fund Discretionary Carry Forward Budget in the amount of**
24 **\$196,969.00 and the FY 2018 Education Department Child Care Services Program**
25 **Child Care and Development Fund Mandatory Carry Forward Budget in the**
26 **amount of \$91,197.00, for a total amount of \$288,166.00 which shall be funded**
27 **from the Nation's general fund pending reimbursement from the grantor.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation chairperson or any designated official is authorized to administer and**
30 **expend the FY 2018 Education Department Child Care Services Program Child**
31 **Care and Development Fund Discretionary and Mandatory Carry Forward**
32 **Budgets, provided however, that any amendments or modifications shall be**
33 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
