

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Baboquivari District Topawa Community Budget Amendment No. 1)**

RESOLUTION NO. 18-154

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and shall expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairperson
10 or vice chairperson of the district council.

12 **WHEREAS,** the FY 2018 Baboquivari District Budgets were approved by Tohono O'odham
13 Legislative Council Resolution No. 17-419 in the amount of \$3,255,026.67; and

14 **WHEREAS,** by Baboquivari District Council Resolution No. 2018-B-24, the Baboquivari
15 District has authorized and submitted for review and approval its FY 2018
16 Baboquivari District Topawa Community Budget Amendment No. 1, which is
17 incorporated by this reference and which will add new language to and adjust
18 operational and/or personnel line items; and

19 **WHEREAS,** the FY 2018 Baboquivari District Topawa Community Budget Amendment No. 1
20 will not change the Topawa Community Budget amount of \$355,233.10 nor the
21 overall Baboquivari District budget amount of \$3,255,026.67; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed FY 2018 Baboquivari District
23 Topawa Community Budget Amendment No. 1 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2018 Baboquivari District Topawa Community Budget Amendment No. 1,
26 which does not change the Topawa Community Budget amount of \$355,233.10,
27 nor the overall Baboquivari District budget amount of \$3,255,026.67.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018
29 Baboquivari District Topawa Community Budget as amended shall be managed
30 and expended in accordance with Article IX, Section 7 of the Constitution of the
31 Tohono O'odham Nation and the Nation's laws, provided that any amendments or
32 modifications shall be authorized under District Council resolution and
33 submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day of MAY, 2018 at a meeting at which a quorum was present with a vote of 2,827.7 FOR; -0- AGAINST; [01] NOT VOTING; and 256.9[05] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
