12		lobbying line items; and
13	WHEREAS,	the FY 2018 Executive Branch Executive-Administration Provisions Lobby Budget
14		Amendment No. 1 will increase the FY 2018 Executive Branch Executive-
15		Administration Provisions Lobby Budget by \$65,600.00 from \$845,745.00 to
16		\$911,345.00; and
17	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2018 Executive Branch
18		Executive-Administration Provisions Lobby Budget Amendment No. 1 and
19		recommends its approval.

24		surplus.

29		modifications shall be submitted for prior approval by the Tohono O'odham
30		Legislative Council.
