

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Executive Branch Executive-Administration Provisions  
Lobby Budget Amendment No. 1)**

**RESOLUTION NO. 18-164**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Executive Branch Executive-Administration Provisions Lobby Budget**  
8 **in the amount of \$845,745.00 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**  
10 **2018 Executive-Administration Provisions Lobby Budget Amendment No. 1,**  
11 **which is incorporated by this reference and which will increase operational and**  
12 **lobbying line items; and**

13 **WHEREAS, the FY 2018 Executive Branch Executive-Administration Provisions Lobby Budget**  
14 **Amendment No. 1 will increase the FY 2018 Executive Branch Executive-**  
15 **Administration Provisions Lobby Budget by \$65,600.00 from \$845,745.00 to**  
16 **\$911,345.00; and**

17 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2018 Executive Branch**  
18 **Executive-Administration Provisions Lobby Budget Amendment No. 1 and**  
19 **recommends its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2018 Executive Branch Executive-Administration Provisions Lobby Budget**  
22 **Amendment No. 1 effective October 1, 2017, which includes a \$65,600.00 increase**  
23 **from \$845,745.00 to \$911,345.00 that shall be funded by Nation's general fund**  
24 **surplus.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation chairperson or any designated official is authorized to administer and**  
27 **expend the FY 2018 Executive Branch Executive-Administrations Provisions**  
28 **Lobby Budget as amended, provided however, that any amendments or**  
29 **modifications shall be submitted for prior approval by the Tohono O'odham**  
30 **Legislative Council.**



6 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
7 **18, 1934 (48 Stat.984).**


