

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Planning and Economic Development Department Bureau of Indian Affairs Realty Program P.L. 93-638 Budget Amendment No. 1)

RESOLUTION NO. 18-183

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Planning and Economic Development Department Bureau of Indian
8 Affairs Realty Program P.L. 93-638 Budget in the amount of \$29,506.88 was
9 approved by Resolution No. 17-438; and

10 **WHEREAS,** the Nation's Grants and Contracts Office notified the Planning and Economic
11 Development Department Realty Program of a cumulative savings of \$148,641.10
12 to be added to the FY 2018 Planning and Economic Development Department
13 Bureau of Indian Affairs Realty Program P.L. 93-638 Budget; and

14 **WHEREAS,** the Realty Program has prepared and submitted for review and approval its FY
15 2018 Budget Amendment No. 1, which is incorporated by this reference and which
16 will create new line items, adjust operational and/or personnel line items, and
17 roll-over the amount of \$30,773.26 into FY 2019; and

18 **WHEREAS,** the FY 2018 Planning and Economic Development Department Bureau of Indian
19 Affairs Realty Program P.L. 93-638 Budget Amendment No. 1 will increase the
20 budget amount by \$117,867.84 from \$29,506.88 to \$147,374.72; and

21 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees of
22 the Legislative Council have reviewed the FY 2018 Planning and Economic
23 Development Department Bureau of Indian Affairs Realty Program P.L. 93-638
24 Budget Amendment No. 1 and recommend its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2018 Planning and Economic Development Department Bureau of Indian
27 Affairs Realty Program P.L. 93-638 Budget, which includes a \$117,867.84 increase
28 from \$29,506.88 to \$147,374.72 that shall be funded by FY 2017 cumulative
29 savings.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
31 Nation chairperson or any designated official is authorized to administer and
32 expend the FY 2018 Planning and Economic Development Department Bureau of
33 Indian Affairs Realty Program P.L. 93-638 Budget as amended, provided that any


amendments or modifications shall be submitted for prior approval by the
Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
