**RESOLUTION NO. 18-189**

1   **WHEREAS,**    the Tohono O'odham Legislative Council is authorized "to manage any funds  
2                    within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3                    these funds for the benefit of the nation and its members" provided that "[a]ll  
4                    expenditures of these funds shall be pursuant to appropriations or budgets"  
5                    authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6                    Nation, Article VI, Section 1(d)(2)); and

7   **WHEREAS,**    the Department of Health and Human Services ("DHHS") Senior Services Program  
8                    has prepared and submitted for review and approval its:

- 9                    (1)    FY 2019 Title III B Transportation Budget in the amount of \$23,850.00,
- 10                   (2)    Title III C-1 Congregate Budget in the amount of \$41,073.00,
- 11                   (3)    Title III C-2 Home Delivered Meals Budget in the amount of \$28,435.00,
- 12                   (4)    Title III E Outreach Budget in the amount of \$3,966.00,
- 13                   (5)    Title III LTC Ombudsman Budget in the amount of \$5,000.00,
- 14                   (6)    Title III Training Budget in the amount of \$3,987.00,
- 15                   (7)    Title III Caregiver Information and Referral Budget in the amount of  
16                    \$3,000.00, and
- 17                   (8)    Title III HPR CDSMP Budget in the amount of \$1,000.00 (collectively, "Title  
18                    III Budgets"), all of which are incorporated by this reference and all of  
19                    which are to be funded from the Nation's general fund pending  
20                    reimbursement by the grantor, Title III of the Older Americans Act  
21                    through the Inter-Tribal Council of Arizona

23   **WHEREAS,**    the Health and Human Services and Budget and Finance Committees have  
24                    reviewed the FY 2019 DHHS Senior Services Program Title III Budgets and  
25                    recommend their approval.

26   **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
27                    FY 2019 DHHS Senior Services Program Title III Budgets effective July 1, 2018 that  
28                    shall be funded by the Nation's general fund pending reimbursement by the  
29                    grantor, Title III of the Older Americans Act through the Inter-Tribal Council of  
30                    Arizona.

31   **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
32                    Nation chairperson or any designated official is authorized to administer and  
33                    expend the FY 2019 DHHS Senior Services Program Title III Budgets, provided that
