11		which will increase operational line items and a one-time increase under the
12		capital line item; and
13	WHEREAS,	the FY 2018 General Services Motor Pool Budget Amendment No. 1 will increase
14		the FY 2018 General Services Motor Pool Budget by \$126,500.00 from \$696,703.75
15		to \$823,203.75; and
16	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2018 General Services
17	1 1	Motor Pool Budget Amendment No. 1 and recommend its approval.
18	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
19		FY 2018 General Services Motor Pool Budget Amendment No. 1 effective October
20		1, 2017, which includes a \$126,500.00 increase from \$696,703.75 to \$823,203.75
21		that shall be funded by the Nation's general fund surplus.
