

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Education Tohono O'odham Language Teacher
Certification Unit Budget Amendment No. 1)**

RESOLUTION NO. 18-206

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Education Tohono O'odham Language Teacher**
8 **Certification Unit Budget in the amount of \$22,750.00 was approved by Resolution**
9 **No. 17-426; and**

10 **WHEREAS, the Department of Education has prepared and submitted for review and**
11 **approval its FY 2018 Tohono O'odham Language Teacher Certification Unit**
12 **Budget Amendment No. 1, which is incorporated by this reference and which will**
13 **adjust operational line items; and**

14 **WHEREAS, the FY 2018 Department of Education Tohono O'odham Language Teacher**
15 **Certification Unit Budget Amendment No. 1 will not change the overall budgeted**
16 **amount of \$22,750.00; and**

17 **WHEREAS, the FY 2018 Department of Education Tohono O'odham Language Teacher**
18 **Certification Unit Budget Amendment No. 1 will change the FY 2018 Tohono**
19 **O'odham Language Teacher Certification Unit Budget line item narrative**
20 **descriptions for operational line items; and**

21 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
22 **reviewed the FY 2018 Department of Education Tohono O'odham Language**
23 **Teacher Certification Unit Budget Amendment No. 1 and recommend its**
24 **approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
26 **FY 2018 Department of Education Tohono O'odham Language Teacher**
27 **Certification Unit Budget Amendment No. 1 effective October 1, 2017 which will**
28 **not change the overall budgeted amount of \$22,750.00.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation chairperson or any designated official is authorized to administer and**
31 **expend the FY 2018 Department of Education Tohono O'odham Language Teacher**
32 **Certification Unit Budget as amended, provided however, that any amendments**
33 **or modifications shall be submitted for prior approval by the Tohono O'odham**
34 **Legislative Council.**
