

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Public Safety Tohono O'odham Nation Police
West Valley Resort Budget Amendment No. 1)

RESOLUTION NO. 18-207

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Public Safety Tohono O'odham Nation ("TON") Police**
8 **West Valley Resort ("WVR") in the amount of \$2,266,977.60 was approved by**
9 **Resolution No. 17-437; and**

10 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
11 **approval its FY 2018 TON Police WVR Budget Amendment No. 1, which adjusts**
12 **personnel and operational line items; and**

13 **WHEREAS, the FY 2018 Department of Public Safety TON Police WVR Budget Amendment No.**
14 **1 will not change the original budget amount of \$2,266,977.60; and**

15 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
16 **2018 Department of Public Safety TON Police WVR Budget Amendment No. 1 and**
17 **recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2018 Department of Public Safety Tohono O'odham Nation Police West Valley**
20 **Resort Budget Amendment No. 1, effective October 1, 2017, which does not change**
21 **the original budget amount of \$2,266,977.60.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2018 Department of Public Safety Tohono O'odham Nation Police**
25 **West Valley Resort Budget as amended, provided however, that any amendments**
26 **or modifications shall be submitted for prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
29 **day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 2,853.5 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and 231.1 [04] ABSENT, pursuant to the powers vested in the Council**
31 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
32 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**
