

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2018 Department of Public Safety 638 Corrections Program
Budget Amendment No. 2)**

RESOLUTION NO. 18-208

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Public Safety 638 Corrections Program Budget in the**
8 **amount of \$4,434,648.32 was approved by Resolution No. 17-438; and**

9 **WHEREAS, the FY 2018 Department of Public Safety 638 Corrections Program Budget**
10 **Amendment No. 1 was approved by Resolution No. 18-137 in the amount of**
11 **\$6,122,062.25; and**

12 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
13 **approval its FY 2018 638 Corrections Program Budget Amendment No. 2 which is**
14 **incorporated by this reference and which will adjust operational line items; and**

15 **WHEREAS, the FY 2018 Department of Public Safety 638 Correction Program Budget**
16 **Amendment No. 2 will increase the Department of Public Safety FY 2018 638**
17 **Corrections Program Budget by \$681,318.40 from \$6,122,062.25 to \$6,803,380.65;**
18 **and**

19 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
20 **2018 Department of Public Safety 638 Corrections Program Amendment No. 2 and**
21 **recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2018 Department of Public Safety 638 Corrections Program Budget**
24 **Amendment No. 2 which includes a \$681,318.40 increase from 6,122,062.25 to**
25 **\$6,803,380.65 that shall be funded by FY 2017 carryover savings.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2018 Department of Public Safety 638 Corrections Program Budget**
29 **as amended, provided however, that any amendments or modifications shall be**
30 **submitted for prior approval by the Tohono O'odham Legislative Council.**


