

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Membership Services Enrollment Committee Budget
Amendment No. 1)**

RESOLUTION NO. 18-210

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Membership Services Enrollment Committee Budget**
8 **in the amount of \$46,210.32 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the Department of Membership Services has prepared and submitted for review**
10 **and approval its FY 2018 Enrollment Committee Budget Amendment No. 1, which**
11 **is incorporated by this reference and which will adjust operational and**
12 **personnel line items; and**

13 **WHEREAS, the FY 2018 Department of Membership Services Enrollment Committee Budget**
14 **Amendment No. 1 will not change the total budget amount of \$46,210.32; and**

15 **WHEREAS, the Rules and the Budget and Finance Committees of the Tohono O'odham**
16 **Legislative Council have reviewed the FY 2018 Department of Membership**
17 **Services Enrollment Committee Budget Amendment No. 1 and recommend its**
18 **approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2018 Department of Membership Services Enrollment Committee Budget**
21 **Amendment No. 1, which will not change the overall budgeted amount of**
22 **\$46,210.32.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2018 Department of Membership Services Enrollment Committee**
26 **Budget as amended, provided however, that any amendments or modifications**
27 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
29 **day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 2,853.5 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and 231.1 [03] ABSENT, pursuant to the powers vested in the Council**
31 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
32 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**
