

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of SAWRSA Trust Fund Monies to Cover Printing of the  
Small Reclamation Loan Application for Schuk Toak New Farm  
Budget Modification #2)

RES. NO. 149-90

1 WHEREAS, the Tohono O'odham Legislative Council convened in a  
2 meeting on May 9, 1990 to consider approval of the use of  
3 monies for reproduction costs for the Schuk Toak Small  
4 Reclamation Loan Application; and

5 WHEREAS, this budget will enable the Water Project Office to pay  
6 for reproduction of 60 copies of the Small Reclamation  
7 Loan Application from the SAWRSA Trust Fund. Consequently  
8 the Water Projects Office will distribute copies to the  
9 appropriate authorities including the Bureau of  
10 Reclamation; and


11 WHEREAS, the Tohono O'odham Legislative Council realizes that under  
12 SAWRSA the Nation is responsible for land subjugation and  
13 that the Small Reclamation Loan will be used for purposes  
14 of land subjugation; and

15 WHEREAS, this budget modification covers the Nation's expense for  
16 reproduction of the Small Reclamation Loan Application at  
17 a cost of \$937.32 .

18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
19 Council does hereby approve the budget modification and  
20 establishes an office supplies line item of \$937.32 from  
21 the SAWRSA Trust Fund to cover reproduction costs for  
22 printing the Schuk Toak Small Loan Application.

23 The foregoing Resolution was passed by the Tohono O'odham Council  
24 on the 9th day of May, 1990 at a meeting at which a quorum was  
25 present with a vote of 1,584.0 for; -0- against; 140.0 not voting;  
26 05 absent, pursuant to the powers vested in the Council by Section  
27 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham  
Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
